Greetings from St Mary's Leadership – thank you for your continuing support through recent months. Here is a finance update for both 2021 and looking forward to 2022.

Looking Back and Giving Thanks

It's important that our starting point is one of giving thanks to God for his provision through the last two years. Although all our lives have been turned upside down in various ways by Covid19, God has been ever-present with us throughout the pandemic and continues to walk with us through all changing scenes of life.

Some areas of Church life to give thanks for include (and there are others):

- ◆ The Church's pastoral care of people
- ◆ Those who have worked tirelessly to provide attended services
- ◆ The Youth work
- ◆ The livestreaming of services
- ◆ The regular paper resources for those without computer access
- ◆ The Church Bible & Kitchen Projects funded by donations and grants (not general giving)

When we come to the church's finances, savings made during 2021 include:

- Using the Government Furlough Scheme saved £3,000 (this is in addition to the £10,000 saved in 2020)
- Staffing savings were made due to a combination of Parental leave and Tim not having a PA for the last 3 months of 2021 saving £7,500
- General expenses have been much lower

These combined savings amounting to over £12,000 have helped us balance the budget this year without the need for a Gift Day. Thanks be to God! However, these savings won't be repeated in 2022.

Looking Forward and Trusting God

Looking Forward and Trusting God

2022's budget has been the most challenging budget St Mary's has had to prepare in many years. Factors influencing this include:

- ◆ No Furlough scheme
- ◆ We anticipate staffing levels being restored to their 2019 levels
- ◆ A loss of nearly £10,000 in regular giving due to changes in people's circumstances
- ◆ A small increase in Parish Share
- ◆ Increases in energy costs
- ◆ General Church Expenses will increase back to their normal levels (this reflects the resumption of church activities, ministries and events)

If we were to resource St Mary's to the same level as we did in 2019, the above factors add up to a **shortfall of nearly £27,000**. This, the PCC felt, was not realistic in the current climate.

After much prayer and debate, the PCC has reluctantly agreed to reduce two areas in the short term: World Mission and PA support to Tim. Both of these have been reduced by 50%, saving £9628.

With these savings, we still face a shortfall in 2022 of around £17,000.

We believe we can meet this £17,000 shortfall challenge if everyone plays their part. However, our ability to support essential mission, allowing the Gospel message to be taken out in our local community and beyond, will be shaped in 2022 by our financial position.

Regular giving supports the key work of St Mary's and we are all called to be good stewards of our resources.

Once we have financial clarity for 2022, the PCC plans to revisit the budget.

How you can help

Two Things To Do:

The **first thing** we need to do is to come before the Lord and ask him what he wants you to give of all he has entrusted you with.

This could be a one-off gift or an increase in regular giving - it could be both! Increases in regular giving will help the church to resource its ongoing ministry and keep the church's finances on a firm footing for the future.

The **second thing** to do is to complete the Pledge Response form on the next page. It includes both options to give a one-off gift and a pledge to increase one's regular giving.

There is also the opportunity to start supporting St Mary's if this is new to you.

Please prayerfully consider your response, indicating which option(s) you can support at this time and return to the church **by Sunday 9 January 2022**.

All responses are handled by the Treasurer in complete confidence.
